- ***Proper attire required (safety helmet, shoes with heels, and long pants.)***
- ***No Horse Play***
- ***No pets allowed***
- ***No open toe shoes in barnyard or around horses***
- ***No climbing on gates or fences***
- ***No feeding horses without permission***
- ***All guests under the age of 12, not participating in lessons must be attended by an adult at all times.***
- ***Lead ropes are required at all times for moving horses. ONLY LEAD ONE HORSE AT A TIME!***
- ***No food, candy or gum consumption while riding horses.***
- ***No smoking or use of tobacco products while on premises.***
- ***No excessive sounds or sudden movement***
- ***No colliding with another horse or object***
- ***INSTRUCTOR'S WORD IS FINAL!***
